


Resolutions and Board Elections

AGM Process

Voting

- Your voting representative will receive a unique voting token via e-mail at 17:00 UTC on Thu 28th

Board Elections

- Voting is by Single Transferable Vote, rank candidates in descending order of preference
- You may vote for as few or as many as you wish
- Voting starts at 17:00 UTC on Thu 28th Oct ("tonight")
- Voting closes at 16:59 UTC on Fri 29th October
